Ushbu maqola J. D. Salingerning adabiy asarlarini har tomonlama tahlil qilib, mavzular, xarakterlarni rivojlantirish va bayon qilish texnikasiga bagʻishlangan. Uning asosiy asarlarini, shu jumladan "Javdardagi ovchi", "Toʻqqiz hikoya" va "Franni va Zooey" ni oʻrganib, ushbu tadqiqot Salingerning zamonaviy adabiyotga ta'sirini tushunish uchun aralash usullardan foydalanadi. In addition to "The Catcher in the Rye," Salinger's other significant works include "Nine Stories" (1953), a collection of short stories, and "Franny and Zooey" (1961), which explores the lives of the Glass family. These works further exemplify Salinger's preoccupation with themes of spiritual longing, personal authenticity, and the impact of societal pressures on individual identity. His distinctive narrative voice and ability to convey deep psychological insights have earned him a lasting legacy in the literary world.

Critics have also explored the autobiographical elements in Salinger's works. Shields (2019) argues that Salinger's own experiences, including his wartime trauma and subsequent retreat from public life, are reflected in his characters' struggles with identity and belonging [2, p. 201]. This biographical approach provides insights into the motivations behind Salinger's writing and the recurring motifs in his stories.
